## ORDER OF DISMISSAL

On or about October 29, 2015, the City of Providence, Board of Licenses ("Board") issued a decision regarding the Class BV license ("License") of Sabor Latino LLC d/b/a iBar ("Appellant"). The Board suspended the Appellant's License for four (4) days; however, the Appellant had already served said suspension. The Board also imposed administrative penalties and restricted its closing time to midnight. Pursuant to R.I. Gen. Laws § 3-7-21 et seq., the Appellant appealed the Board's decision to the Director of the Department of Business Regulation ("Department") and requested a stay of the mandated closing time. The Board objected to a stay. On November 9, 2015, the undersigned was appointed the hearing officer by the Director of the Department. By order dated November 13, 2015, the Department issued a conditional stay. Prior to a hearing on this matter, the matter was resolved and on August 24, 2016, the Appellant informed the undersigned that this matter could be dismissed. Therefore, based on the forgoing, the Appellant's appeal is dismissed.
