The Consumer and Governmental Affairs Bureau (Bureau) of the Federal Communications Commission (Commission) seeks comment on two applications for certification to provide Internet-based telecommunications relay service (TRS) supported by the Interstate Telecommunications Relay Services (TRS) Fund: (1) the application of Sorenson Communications, LLC (Sorenson), for certification to provide Video Relay Service (VRS) supported by the Interstate Telecommunications Relay Services (TRS) Fund; and (2) the application filed by CaptionCall, LLC, (CaptionCall), for certification to provide Internet Protocol Captioned Telephone Service (IP CTS) supported by the Interstate TRS Fund. In 2022, the Bureau granted Sorenson and CaptionCall conditional certification to provide VRS and IP CTS, respectively, after the acquisition of majority ownership and control of these entities by Ariel GP Holdco, LLC ("Ariel"). The Bureau conditioned those grants on Sorenson and CaptionCall filing these applications for full certification under their new ownership.

Both Sorenson and CaptionCall have redacted portions of their applications for which they request confidential treatment.<sup>5</sup> Access to the redacted material is governed by the Third Protective Order in this docket.<sup>6</sup>

Filing Requirements. Interested parties may file comments on or before the dates indicated above. All filings must reference CG Docket Nos. 10-51 and 03-123. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS).<sup>7</sup>

Persons making oral ex parte presentations are reminded that memoranda summarizing the presentation must (1) list all persons attending or otherwise participating in the meeting at which the ex parte presentation was made, and (2) summarize all data presented and arguments made during the presentation. If the presentation consisted in whole or in part of the presentation of data or arguments already reflected in the presenter's written comments, memoranda or other filings in the proceeding, the presenter may provide citations to such data or arguments in his or her prior comments, memoranda, or other filings (specifying the relevant page and/or paragraph numbers where such data or arguments can be found) in lieu of summarizing them in the memorandum.
