ORDER REGARDING RE-SCHEDULED SITE VISIT

Pursuant to the Order Re Further Deadlines [filed August 31, 2017], Maui Tomorrow Foundation, Inc. submitted "Suggested Locales of Maui Tomorrow Foundation, Inc. and Its Supporters for Commission Site Inspection" and Nā Moku Aupuni O Koʻolau Hui, Lurlyn Scott and Sanford Kekahuna submitted the "Submittal Regarding Commission Site Visit on October 2-3, 2017," both of which were received on September 15, 2017.

On September 26, 2017, the Commission on Water Resource Management (CWRM) issued an Order Regarding Site Visit in which it announced its intention to visit various locations within East Maui. The Commission intended to conduct the site visit without any parties being present. After Maui Tomorrow Foundation, Inc. filed an Objection to Exclusion of Parties from Site Visit Inspection on September 29, 2017, the Commission vacated the Order Regarding Site Visit. The Commissioners continue to believe that a site visit may be useful prior to the Commission issuing its final decision in this case.

In consideration in part of the above, the Commission will conduct a site visit to east Maui on November 29, 2017 in which they will attempt to see the following on the indicated schedule:
