The total number of indictments is now 88. Warrants for arrests were to be issued this afternoon.

REDUCTION IN LIVING COSTS

Prices of Foodstuffs Used by State Dropped During Last Year.

Prices of food stuffs, clothing, meats, flour and other supplies used by the state have steadily dropped during the last year. A material saving was announced by members of the state board of administration on all commodities.

Prices of bacon dropped from \$17.94 per 100 pounds in 1914 to \$13.47 this year. Salt meats declined from \$22.53 to \$17.85 and ham slumped in price in 1920 from \$14.44 to \$12.29. Quality of supplies has improved, board members asserted, while prices dropped.

The state's semi-annual letting called for contracts amounting to \$27,840.48, distributed as follows:
