












## Clark Fork - Pend Oreille River Adjudication

- · Petition filed on October 23, 2020.
- · Hearing on Petition was held on January 21, 2021.
- Continued Hearing on Petition held on May 24, 2021.
- Memorandum Decision on Petition to Commence and Order for the CFPRBA issued on June 15, 2021.
- · Notice of Appeal filed on July 27, 2021.
- Commencement Notices mailed to approximately 5,000 property owners in the Priest River Basin (Basin 97) on September 2, 2021.

# Bear River Basin Adjudication (BRBA)

- · Petition filed on November 20, 2020.
- Hearing on Petition was held March 4, 2021.
- Continued Hearing on Petition held on May 24, 2021.
- Memorandum Decision on Petition to Commence and Order for the CFPRBA issued on June 15, 2021.
- Notice of Appeal filed on July 27, 2021.
