 - c. Tom Hadden introduced Stacie Johnson, Eastern Iowa Coordinator, Iowa Stormwater Education Program (ISWEP) Johnson provided a review of stormwater regulations in Iowa and how MS4 communities are addressing the rules and incorporating improved stormwater practices into the design of infrastructure. MS4 communities represent 42% of Iowa's population yet less than 5% of Iowa's land surface. ISWEP is developing a certification program for individuals involved in erosion and sediment control. The ISWEP website is www.IowaStormwater.Org.
 - d. Hadden introduced Wayne Petersen, Urban Conservationist, Iowa Department of Agriculture and Land Stewardship Petersen provided a virtual tour of low impact development in Iowa showing examples of many practices and locations. He indicated that 42% of urban infrastructure will be rebuilt by 2030 and incorporating low impact development practices need to be a part of the redevelopment.
