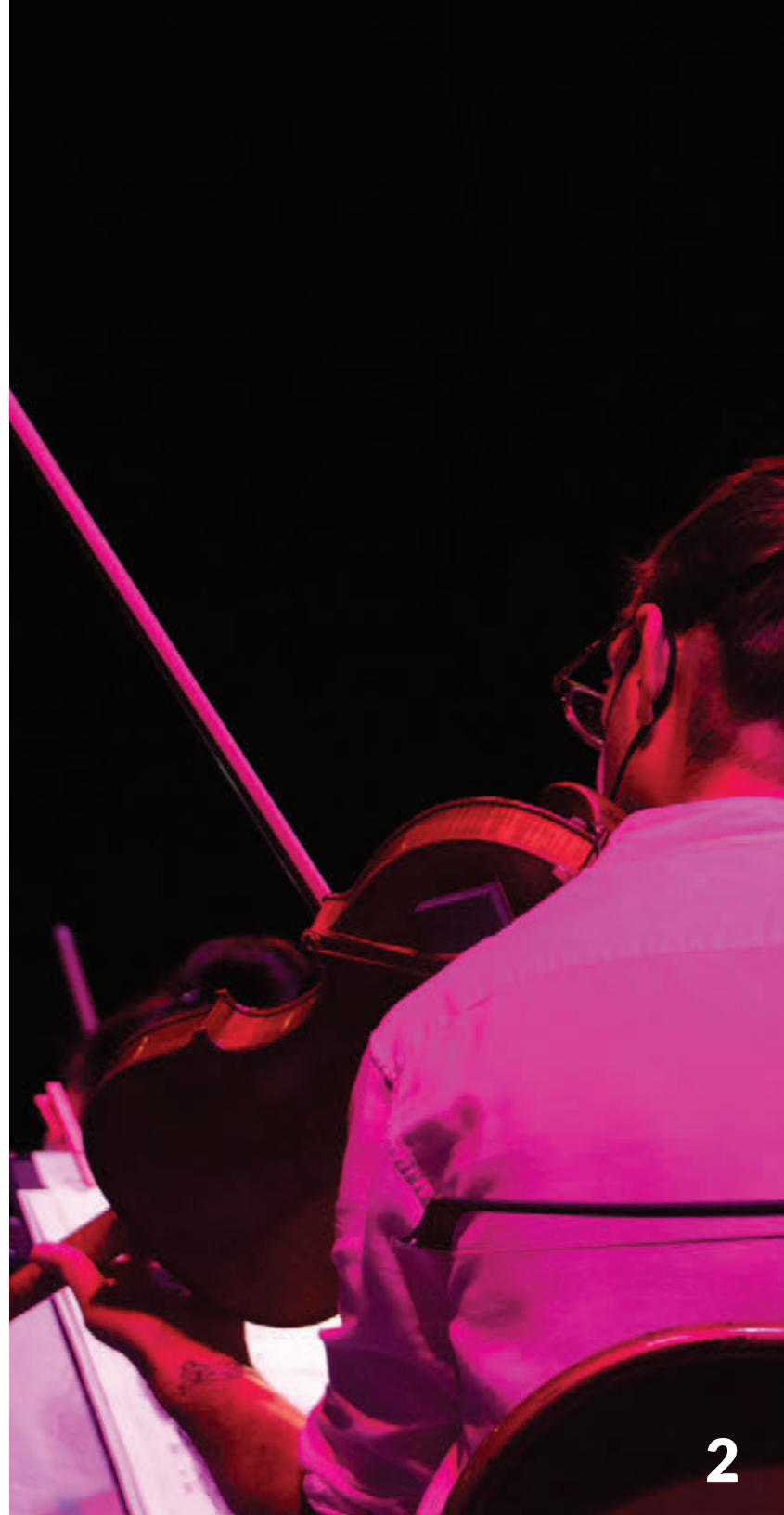

ABOUT LEXPHIL

Originally named the Central Kentucky Philharmonic Society, the Lexington Philharmonic Orchestra (LexPhil) was created in 1961 to provide background music for a film produced by the Department of Agriculture at the University of Kentucky. The orchestra was made up of about 65 volunteer musicians, many of whom were faculty and students at surrounding colleges and universities, including the University of Kentucky, Morehead State University, Eastern Kentucky University and graduates of the Central Kentucky Youth Orchestra. The Philharmonic's first season consisted of three concerts, all performed at Henry Clay High School; the cost of a full season subscription was just \$5 per adult, \$2.50 per student and \$12.50 per family!

In July 1961, Robert King was named first Music Director and Conductor of the Central Kentucky Philharmonic Society, which then became the Lexington Philharmonic Orchestra in 1965. During his tenure, King helped develop the group of 65 musicians into a cohesive orchestra, which soon became the largest arts organization in central Kentucky. Leo Scheer joined LexPhil in 1965 as Music Director and Conductor. Scheer, a native of Jersey City, NJ, was the first conductor of LexPhil to implement a policy of paying all musicians, who had previously been members of the orchestra on a volunteer basis. Scheer was Music Director for six seasons before he resigned in 1971.

In 1972, Dr. George Zack joined LexPhil as Music Director and Conductor after a year-long search during the 71-72 season. Dr. Zack was chosen by a committee made up

of sponsors, LexPhil Board Members, members of the LexPhil Guild, and the principal musician of each section of the orchestra. Dr. Zack served as LexPhil's Music Director for 37 years before his retirement in 2009. A native of Arkansas, Dr. Zack has been an incredible presence in not only the history of the LexPhil orchestra, but in the Lexington community. In April 2009, Scott Terrell was named Music Director and Conductor of LexPhil after a two-year search that drew from 278 applications. A native of Michigan, Terrell worked with the Charleston Symphony Orchestra for five years prior to joining LexPhil and was the Assistant Conductor of the Minnesota Orchestra from 1998-2003. Maestro Terrell led the orchestra for ten years, his tenure concluding in May of 2019.

In summer of 2022, LexPhil announced the appointment of Mélisse Brunet as Music Director following a national three-year search interrupted by the Covid-19 pandemic. Brunet officially assumed the role of Music Director during the 2022 - 2023 Season, with an initial term of five years. Since LexPhil's founding in 1961, Brunet is the orchestra's fifth Music Director and the first woman to hold the position. Today, LexPhil provides over 200 concerts, education and community programs every year, engaging communities across the region and reaching thousands of students in schools. With educational programming such as Sound Explorers! kids concerts, Instrument Petting Zoos, Teaching Artists, and In-School Programs, LexPhil is reaching beyond the traditional realms of orchestral music presentation to provide innovative and exciting opportunities in music across the Bluegrass.





LETTER FROM EXECUTIVE DIRECTOR

In so many ways, this season has felt like a new beginning with a different definition of success; a definition that is more community oriented, more accessible and more joyful! The world has changed and LexPhil is changing too. We are welcoming new voices and bringing them to the table. As with any living, engaged entity, we have evolved and I am so proud of the direction we have chosen.

This year, we welcomed our new Music Director, Méliisse Brunet. I have had the immense pleasure of getting to know Méliisse over this year and I have full faith and trust that she is the right person to provide artistic leadership as LexPhil continues to evolve. I look forward to seeing all the new ways our music community steps up to support her work and vision.

Professional orchestras are complex and expensive entities. They require constant care and support at all levels. The work of managing a successful professional orchestra has not gotten any easier and in fact has become more complex as we endeavor to be meaning makers for our community in these turbulent times. No matter what the challenge though, it is important and vital work we do. One of the reasons LexPhil will continue to be able to navigate uncertainty is because of the steadfast leadership demonstrated by our Board of Directors, and Foundation Board, and the ever-amazing skill and dedication of our staff and musicians. Combined, they are unstoppable. They are the definition of 'punching above weight', effective checks and balances, careful stewardship, and confident innovation.

As you have heard, I will be stepping down from the role of Executive Director this summer. These thirteen years of being part of the LexPhil leadership team have presented great challenges and rewards. While I am looking forward to pursuing some other interests and taking care of myself, I will greatly miss all of you. Music-making is what we are known for but the life and heartbeat of an orchestra is people. Music exists because it is an irreplaceable communication tool. While striving for artistic excellence is always a noble goal, it is the interchange between people playing, teaching, listening to music, live, and in the moment, that is most important. The powerful, communal sharing of heartbeat and breath synchronizing to the music, the shared awe and emotional release is what it's all about.

I thank each and every one of you for the support and hard work you put into making LexPhil a leader and pillar of central Kentucky culture. We can all be proud of the role LexPhil plays and the way it supports community. And even as we faced challenges and disagreements, I am proud of the integrity and careful thought that supported each decision. With LexPhil, I've always felt like I've been part of something larger than the sum of its parts. There is nothing more rewarding.

The Lexington Philharmonic Orchestra Foundation, Inc. ("Foundation") was formed in November 1977 as a separate 501(3)(c) entity. The Foundation exists to secure long term financial support through public and private sources and to promote philanthropic activity to benefit the annual expenses of the Lexington Philharmonic Society, Inc. ("Society"). John Wharton continues to serve as Chair. John previously served as President of the Society in the mid-90s. We said goodbye to two long-time Foundation Board members, Denise McClelland and Jackie Hamilton, while welcoming new Boardmember Dr. Dean White.

The Foundation's endowment spending policy allowed a \$150,000 disbursement for the Society's annual operating expenses, an increase from the prior year. An additional \$60,000 from the Lou Hedrick Jones Fund was loaned to the Society, free of interest, per the terms of the applicable grant agreement. The Foundation previously loaned the Society \$100,000. As a result of generous donations, the principal balance of this loan has been reduced to \$47,000.

The Foundation provided additional general operating support to the Society in the amount of \$4,204 from funds held in the Lexington Philharmonic Orchestra Fund with the Blue Grass Community Foundation (BGCF). Finally, the Foundation once again funded musician recognition awards by providing \$500 from the Martha Jane

Stone Fund. For next year, the Foundation has approved \$150,000 of financial support for the Society for the 2023-2024 fiscal year, along with appropriate disbursement from the Lexington Philharmonic Orchestra Fund at BGCF and additional disbursements from the Lou Hedrick Jones Fund as needed. Finally, the Foundation approved the use of funds in the amount of \$69,417.90 held in the Composer in Residence Fund maintained with BGCF.

In the fall of 2017, the Foundation initiated the Legacy Society to recognize patrons who commit new gifts to the Foundation, including cash and estate gifts of most any type of assets. Approximately a dozen Society patrons have joined the Legacy Society. As part of your estate plans, please consider the many ways you can make a current or deferred gift

Many of these new programs were received very well, nonetheless LexPhil continues to innovate in order to respond to the needs and wants from our community.

SCHOOL PROGRAMS

The return to normalcy post-pandemic provided the opportunity for LexPhil to return to working in and with schools through reimagined programs with a focus on sustained engagement and making based programs.

School workshops in Frankfort - In November and December, we offered seven workshops with elementary and middle school students in the gifted and talented program in the Franklin County Schools

Fayette County Public Schools - A primary goal for this season was to deepen LexPhil's partnership with Fayette County Public Schools. Working closely with Katherine Lowther, FCPS Director of Fine Arts, LexPhil developed and implemented semester-long residencies at three schools: Ashland Elementary School, Crawford Middle School's Extra Innings program, and STEAM Academy.

Through 15 one hour sessions that met weekly, LexPhil teaching artists led students through a unique and responsive curriculum that promotes and supports students as makers of music and meaning. Students created multiple compositions using various approaches such as text scores, graphic scores, collective improvisation, and music notation software. Students also engaged with mindfulness practices that deepened sonic awareness and promoted social-emotional learning.

This season, the Instrument Petting Zoo was upgraded and modernized to the MusicLab, a portable studio that combines electronic and acoustic instruments and other technology for a fun, hands-on experience that provides an opportunity for participants of all ages and abilities to make music while simultaneously learning about the science of sound and electricity. The MusicLab made numerous appearances at schools, community centers, libraries, and fairs.

CREATIVE AGING

This season, LexPhil launched its first creative aging programs, in partnership with the Lexington-Fayette Urban County Government's Department of Aging and Disability Services, at the Charles Young Center. This emerging field of practice promotes arts engagements for older adults because of the positive physical and mental health benefits.

Over the course of 9 weeks, participants created multiple compositions using various

approaches such as text scores, graphic scores, and collective improvisation. At the end of the program, participants collaborated with LexPhil musicians to interpret and perform compositions they wrote.

MEET, PLAY, & LEARN

In advance of the following four concerts this season, LexPhil hosted Meet, Play, & Learn events - *Limitless*, *Continuous Variation*, *The Power of Influence*, & *Bloom*. These events provided a unique opportunity for students to engage with guest artists through collaborative music making activities, casual conversations, and brief solo performances.

MARKETING & DEVELOPMENT REPORT

From beginning to end, the 2022-2023 Season, RENEWAL, lived up to its promise of representing a fresh direction and time of growth for LexPhil's audiences.

BONJOUR Y'ALL!

The announcement of Mélisse Brunet as the fifth Music Director of the Lexington Philharmonic, the first woman to hold the position, was met with a warm and overwhelmingly positive response from central Kentucky media, in print in the Lexington Herald-Leader, on the airwaves with media partner WEKU 88.9 and local TV outlets, WKYT and LEX18.

“Bonjour Y’all,” the official catch-phrase of the season, was reflected in LexPhil’s messaging across social media, weekly eNewsletters, media pitches, and even a line of “Bonjour Y’all” merchandise on LexPhil’s website. LexPhil also hosted post-concert gatherings following LexPhil performances under the “Bonjour Y’all” banner, allowing for audience members to meet and greet with Mélisse.

SUBSCRIPTIONS RETURN

After a two-year hiatus, the 2022-2023 Season was the first year offering subscriptions since the disruption of the pandemic. LexPhil had **353** subscribers, and achieved **\$69,575** in revenue, surpassing the \$66k goal. This represents a return of just under 50% of LexPhil’s previous subscribers compared to the 2019-2020 Season (pre-Covid). This season, LexPhil reimagined how subscription packages could allow for greater flexibility in concert choices. Subscribers were able to choose any three or more performances to be a part of their subscription, including LexPhil’s general admission events; *Symphonic Stroll* event Frankfort’s Josephine Sculpture Park, and *The Power of Influence* at the Lyric Theatre & Cultural Arts Center.

SINGLE TICKETS

Lexphil achieved 91% (~\$95k) of the single ticket sales goal of \$107k. Single tickets comprised, on average, half of LexPhil audiences throughout the season. Over 700 people attended a LexPhil event for the first time, with the greatest new attendees coming from *Symphonic Stroll*, *Legacy*, and the *Cathedral Christmas Dress Rehearsal*, the first ‘pay what you want’ event offered by LexPhil. Single ticket promotions included weekly email newsletter blasts, a robust schedule of social media posts that highlighted the artists and composers behind the performances, and paid social media spends on Facebook and Instagram to get our events in front of more audiences online.

New subscriptions and single tickets to the 2023-2024 Season: EPIC VOICES go on sale to the public on Monday, July 3, 2023.

SOCIAL MEDIA & CONTENT MARKETING

LexPhil invested more resources into creating engaging content for audiences and potential ticket buyers online, including the launch of LexPhil's TikTok account. To generate excitement and share stories behind LexPhil's concerts, Mélisse Brunet interviewed guest artists and composers throughout the season as part of an online Artist Interview video series. Guests included violinist Simone Porter, violist Jordan Bak, and remarkably, Pulitzer-prize winning composer, Ellen Taaffe Zwillich. These videos were shared on LexPhil's YouTube channel, Instagram, and Facebook. LexPhil's social media followings and platforms grew during the 2022-2023 season, including a 65% increase in the number of posts to Instagram, an increase of 182.4% in impressions on Facebook, and almost 5,000 views of LexPhil videos on YouTube.

LexPhil continued our valued partnership with **WEKU 88.9** to air LexPhil performances on the airwaves and online, and Mélisse was a repeat guest for Tom Martin's weekly public affairs program, **Eastern Standard**.

ANNUAL FUND & PASS THE BATON

The 2022-2023 Annual Fund raised \$170,000 in individual donations, \$20k short of the budgeted \$190k. Print and digital campaigns highlighted the appointment of Mélisse Brunet as Music Director, LexPhil's commitment to increasing access to LexPhil programs by meeting the community where they are, and the need for continued support to revitalize the organization following the Covid-19 pandemic. LexPhil received gifts from 303 returning donors, and gained 69 new donors. The average gift amount in support of LexPhil was \$460.

Through the HSG Foundation 'Renewal' Matching Challenge Grant, issued by LexPhil Board Member Jackie Hamilton Saykaly, LexPhil raised \$20,000 in new support, which was matched \$1 for \$1, and achieved 100% board giving.

Music Director Emeritus & Conductor Laureate Dr. George Zack joined for LexPhi's 2022-2023 finale Bloom concert to "pass the baton" to Mélisse on-stage, and joined as honored guest for a post-concert party at Board member Lou Jones' home. This special event raised just over \$4,000 in ticket sales and donations.



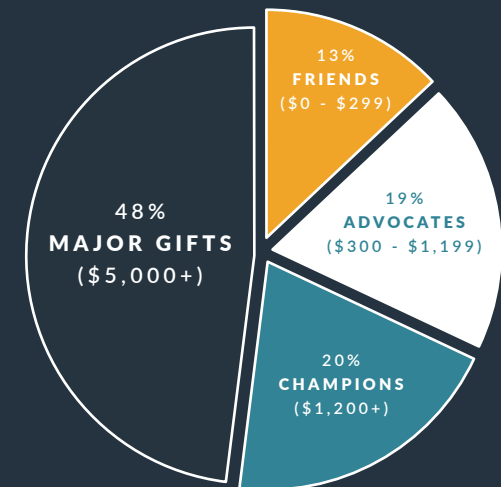

GRANTS & CORPORATE SUPPORT

The Lexington Philharmonic Foundation's allocation of \$154,700 was the largest grantor for LexPhil. Operating support was provided by LexArts at \$100,000, and the Kentucky Arts Council at \$19,284. Grant support also came from Hamilton Saykaly Garbulinska Foundation, The Rotary Club, Kentucky Colonels, and the National Endowment for the Arts. LexPhil secured \$43,000 the budgeted \$80,000 goal for corporate sponsorship.

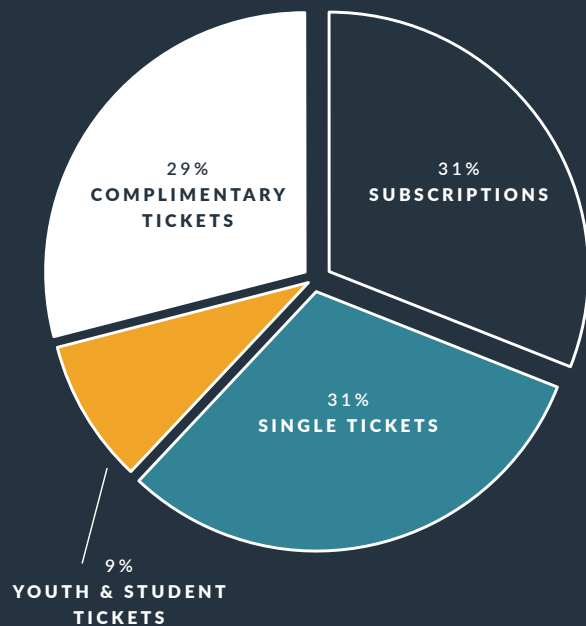

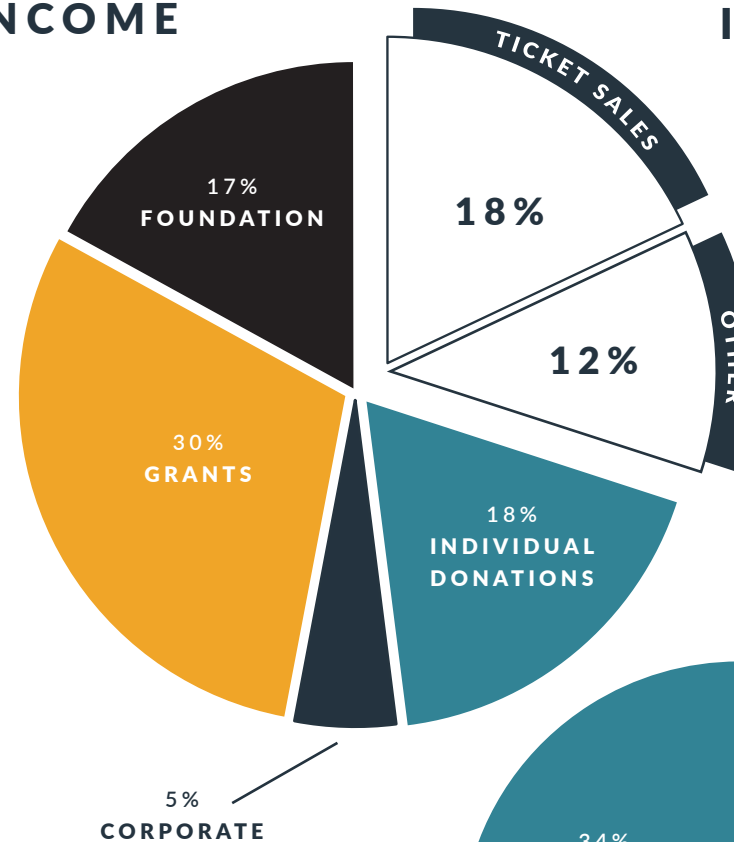

2022 - 2023 FINANCIAL OVERVIEW

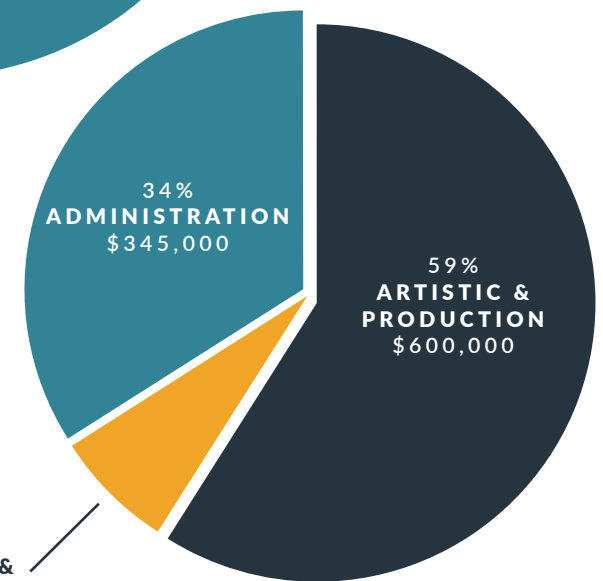
