

How Will NOTIS Deal with Format Integration?

ormat Integration is coming. The Library of Congress says that it will begin distributing records using the new integrated formats in spring of 1994. NOTIS is planning changes to the Library Management System (LMS) and other products to deal with the integrated formats.

In January, the Lib1 Special Interest Group put together a document proposing how NOTIS might best handle Format Integration. That document was quite useful and allowed us to focus our thinking about the Format Integration task.

Below is the NOTIS response to the Lib1 SIG. We are reprinting it here because it contains information important to all customers and tells you quite a lot about how we are going to address Format Integration within the NOTIS software.

Basic Principles

In adapting the NOTIS LMS to Format Integration, NOTIS Systems, Inc. will use the following principles.

Keep Changes Simple and Clear

NOTIS will follow past practice regarding tag tables, etc., wherever possible. Format Integration will need to be implemented quickly; therefore, we want the necessary changes to fit into place easily.

Concentrate on Format Integration Needs

When making changes like this, we need to make choices. NOTIS has chosen to focus on Format Integration.

Distribute Software 1st Quarter

NOTIS understands that customers must have these changes before they begin distributing records in spring of 1994. The Library of Congress has set a target date of April, 1994. We will have all changes to customers prior to April.

Package the Release Alone

Our goal is to make it very easy to get these revisions in place; therefore, we will not package the Format Integration changes with the restructured circulation module or other major program changes.

Format Integration Development on the Release 5.1 Base

To accommodate Format Integration compliance changes, your local system must be at Release 5.1.1.

Response to the SIG Proposals

The following responses to the proposals by the Lib1 SIG are in the order presented.

Tag Tables

Format Integration involves changes to NOTIS tag tables, such as:

- removing "deleted" data elements
- · special handling of "obsolete" data elements
- adding new data elements

Even though individual sites or MARC record "vendors" may update their database to reflect Format Integration, not all sites exchanging records will do this at the same time. Some sites or record distributors may choose never to remove obsolete data elements.

NOTIS believes that it is unnecessary to rewrite the NOTIS tag table structure to provide Format Integration functionality. Consolidating tag table structure creates a number of problems with records in the database. We do not want to force a complete conversion of the bibliographic database and so have chosen the alternative proposal of format-specific validation.

Because of the need to meet record distribution deadlines, support of new MARC-type formats (Classification and Community Information) will not be rolled into the Format Integration project.

NOTIS software will accommodate the presence of obsolete data elements in older records. Such obsolete data may be retained or deleted; however, obsolete elements cannot be maintained (updated) or added to a record. Messaging will support this. GTO will be able to pass obsolete elements.

Changes will be made to the tag tables so that

the printed NOTIS Tag Chart will identify obsolete data elements.

Cataloging edit features will not vary based upon configuration options. As in the past, edit functions will be uniform.

Database and File Conversion Programs

Format Integration does not require changing existing records to remove obsolete data elements, only deleted data elements.

Conversion programs will be unnecessary to implement Format Integration compliance software. The standard for Format Integration clearly states that there is no requirement to remove obsoleted fields. Further, there is no way to accurately predict programmatically new content designation, and we will not attempt to do so.

OPAC screen display definitions in LSYS (as distributed) do not contain references to obsolete or deleted data elements. If a local site has added such definitions, they may want to remove them. (The system will function properly, however, if they are left in.)

Conversion programs will not accompany the release so there will be no conversion-related reports. Guidelines for implementing Format Integration specify that existing records do not need to be altered. If there is interest in a report, an enhancement to QuikReports could be requested.

NOTIS Format Definitions

USMARC Format Integration still requires a cataloger to decide the basic format of an item; this is reflected in the choice of Leader/06 and /07 values and 008 type. In view of this, the NOTIS format code will still be a valid way to identify items and to generate workforms.

Similarly, NOTIS sites will continue to want to specify different OPAC displays for different types of materials based upon format. (Rationalizing data elements across format does not erase significant differences in the applicability or importance of data elements when applied to different types of material.)

The implementation of Format Integration, however, does create the possibility that sites may need to add fields to their OPAC short and long view definition files in order, for instance, to display serial or archival aspects of other basic format types.

NOTIS accepts the recommendation that we

keep the basic "format code" structure the same.

Media descriptors in the 006 field will not show in index displays. This would require a rewrite of the Merged Heading Index, which is inconsistent with the deadline requirements.

NOTIS has modeled OPAC views and sees no need to increase the number of labels allowed. Average LONG displays use 19 or 20 labels. The few (perhaps 3 or 4) additional labels that might be appropriate with Format Integration shouldn't put any implementation of NOTIS beyond the current allowance of 45. (40 different tags may be defined under each label.)

OPAC software will not be rewritten at this time to support display of fixed field elements. Local control via LSYS will permit individual sites to use the expanded use of variable fields, where appropriate. Coded fixed field data that may be useful to OPAC users is generally also available in eye-legible form in a variable field. (For example, "Frequency" is available in tag 310 or 315.)

Although adding secondary format information to records in the 006 fields suggests that that information should also be made indexable, the search engine will not be modified at this time. The suggestion to allow qualification by Type of 006 when qualifying by format is a good one; however, we are unable to do the work on the search engine at this time.

Input and Display of 006 Values

Format Integration involves defining a new fixed field 006, which is used for "Additional Material Characteristics." Field 006 is "self-defining" because the acceptable values in all character positions are predictable from the first byte of the field (and are tied to validity of parallel 008 data elements).

Any type of record may need to include any type of 006. Data in the 006 field will be input in field templates, similar to how the current 007 field is handled.

Data in the 006 field will display at the top of the MARC bibliographic display, along with the Leader, 007, and 008 data elements. Only a small percentage of bibliographic records are actual candidates for an 006, and a very small percentage of those are candidates for multiple 006's.

Coordinate NOTIS Program Updates

Coordination is needed between NOTIS Systems and NOTIS sites, and between NOTIS Systems and the national utilities' (OCLC, RLIN, WLN, UTLAS and LC's) implementation schedules. Internally, NOTIS is coordinating changes among the various programs that are affected by Format Integration.

Format Integration-compliance software will be packaged for distribution essentially as a single issue interim release (plus fixes). Simple implementation will be a major feature of the release.

This software will be distributed in first quarter 1994. This will be at least seven months after Release 5.1.1 is distributed and slightly before the current schedule of the utilities.

Modifications will need to be made to all NOTIS record import/export software—loaders, GTO, BOVL, RLIP TOP, and MARC export. For this purpose, updates to all of this software will be included in the release to fully support Format Integration.

The new software will be able to handle existing bibliographic records (provided they are in valid MARC).

NOTIS' Client/Server Product Line

e want to clarify what is included in NOTIS' Z39.50 client/server product line. This article should help explain our new client/server products and how they work together.

NOTIS has developed three different clients that provide you with Z39.50 access.

- ProPAC—NOTIS' first graphical user interface that makes it easy to access remote library catalogs and other databases compatible with the Z39.50 standard.
- TermPAC—NOTIS' character-based client that operates either on the mainframe or in the UNIX environment. TermPAC allows your library to take advantage of client/server architecture without investing in new hardware.
- PACLink Client Family—Operates on the mainframe and consists of two major components:
- 1. Generic Z39.50 client that NOTIS developed to access any Z39.50 server, such as OCLC® First Search™ and the University of California's MELVYL™ system. If you purchase InfoShare, you automatically receive this client.
- 2. OPAC-based client that is optimized to search NOTIS catalogs. This client contains extended support for such OPAC features as the merged headings index (MHI). If you purchase the NOTIS PACLink client you will receive this client as well.

As you can see, NOTIS produces many types of Z39.50 clients and servers to make it easier for you and your patrons to access information. To find out more about our client/server architecture, contact your marketing representative.

1993 Ballot has been Decided for LMS and **MDAS**

ome of you may already know that NOTIS will not be conducting the LMS/KeyNOTIS Enhancement Ballot in 1993. This decision was made following discussions at the Special Interest Group meetings during ALA Midwinter.

Most customers agreed that the last two annual ballots have not shown much unanimity among the NOTIS customer base. The mixture of items on past ballots was frequently referred to as "apples and oranges."

Discussion also revealed that there is little uniformity among sites in deciding on how to vote. Some sites make every attempt to solicit input from staff, others do not.

It was also clear that while a ballot this year would not be particularly useful, customers want to find other, more satisfactory methods to collect user input on desired enhancements. The emerging library advisory group may also want to discuss this issue.

In contrast, the MDAS users asked NOTIS to continue the MDAS Enhancement Ballot as the process is still satisfactory for MDAS. This ballot will be done as usual in 1993.

We will keep you posted as we continue to consider better ways to solicit customer input.

QuikReports—Working with Acquisitions

his is the fourth and final in a series of articles about the features and uses of QuikReports. This month's QuikReports article focuses on the Acquisitions reports.

June 1993

Monitor Acquisitions Work

You can use the Daily Transaction Report (ACQ001) to monitor work activity, evaluate training needs, and see how busy the department is on any given day. This report may also be useful as a means of justifying additional staff.

How Fast Do Your Vendor's Deliver?

Compare vendor performance with the Vendor Order Analysis Report (ACQ009). This report tells you how long it took for vendors to fill your orders. It lists the fill time for each order and provides an average fill time for each vendor.

Track Standing Orders and Subscriptions Activity

Keep track of new serials orders with the New Subscription/Standing Orders Report (ACQ014). This report also lists title changes for serials and helps you track your site's serials check-in workload. The Open Subscriptions/Standing Orders Report (ACQ015) lists all currently active periodicals; again this helps to track serials workload and maintain your collection.

For the first time, you can track your standing orders by vendors with the Standing Order Vendor List (ACQ016). This report lists the standing orders from each vendor.

Inform Staff and Patrons of New Materials

Keep staff informed of newly acquired materials by making a list based on the Acquired Items Reports, ACQ002. This report lists acquired items within a specified date range. For the cataloging department, it provides a list of new materials to be cataloged. For reference librarians, it provides a list of new materials received by the library.

Check on Items Ordered

Bibliographers can use the Acquisitions Cost Report (ACQ003) to see which items have been received and paid for. You can then check this list against the order request file.

This report will list items within any time period you specify, and it provides summaries, by processing unit and vendor code, of cost and quantities received.

Track Order Productivity for Any Time Period

Run the Items Ordered Report (ACQ006) across varying date ranges to get information about order activity. Run this report weekly as a productivity report, to let you know what was ordered. Run it monthly and annually as a reference for annual summary reports for the acquisitions department.

Identify Items You've Bought and Paid For (or not Paid for Yet)

The Items Received Report (ACQ007) tracks items received and lets you know which items have been paid for and which haven't. It also provides a total number of items received during the dates specified.

Monitor Spending by Expense Class

When you define universal expense classes for all your funds, you can track spending by expense class through the Expense Class Management Report (ACQ022). For example, if you assign postage costs to the same expense class in every fund, this report tells you how much from each fund you spent on postage, and the total spent on postage. If you set up expense classes by material type, this report tells you which funds you used to purchase which materials.

Team NOTIS Focuses on Improving Support

 mproving support for NOTIS customers was once again the primary focus of the Team NOTIS meeting, which was held April 14 at NOTIS corporate headquarters in Evanston. Team members had a chance to react to several support options and to share their own ideas about what type of support would be most helpful.

The day began with demonstrations of new products including ProPAC, NOTIS' Windowsbased OPAC client. Team members said the interface was very clean and professional, and were impressed with how flexible it was to enter commands and view and manipulate result sets.

PTS Records Available on NOTISrv

Several members of the NOTIS Support team spoke about making PTS records available on NOTISrv. Team NOTIS has strongly supported this initiative in the past. PTS records will be searchable by keyword and will include the problem resolution, or an indication of status if the problem has not vet been resolved.

The team also discussed the possibility of an online one-stop troubleshooting facility. This would include what is now maintained in the Troubleshooting Guide, the Abend Codes manual, and the Support Solutions column in NOTISes. It was not clear whether this full capability would be possible immediately, but NOTIS staff were receptive to the idea.

Team NOTIS addressed the question of why sites do not put up new releases right away. The answers included fear of bugs, other major projects in progress, schedule of the academic calendar, lack of impetus if the new features are not strongly desired, and fear of major disruption from a new version. NOTIS has tried to address the items it can by more thorough testing, resulting in fewer bugs, and by making new features optional, to avoid major disruptions.

Online Documentation Options

Jane Larkin, manager of Documentation Services, presented some options for online documentation of the LMS. Options include ASCII files on diskette, access through NOTISrv, CD-ROM distribution, and online books. Each of these options has its advantages and disadvantages; there was no clear consensus as to which would be the best. Reactions varied considerably among the Team NOTIS members, depending on local setups.

Planning UNIX Workshops

Professional Services sent Stuart Miller to discuss technically oriented workshops they are planning. Much of the focus will be on UNIX topics, as many Tech1s have asked for such training in light of a shift at NOTIS toward supporting a mix of mainframe and UNIX products. Professional Services were also interested in any crises that seem to recur at our sites that they could help prepare us for with extra training.

Jim Miesse of Release Integration and Distribution asked Team NOTIS members what type of support was appropriate for early release sites. The members agreed that regular follow-up calls to Tech1's would be a good idea.

Volunteers Needed for Team NOTIS

Finally, the question of Team NOTIS membership was discussed. Two of the current members will step down after this year and will be replaced by volunteers from the NOTIS community. A call for new members will go out in May so they can be discussed at the next Team NOTIS meeting in July. New members will join the old members and the Programming SIG chairs at the Team NOTIS meeting in conjunction with NUGM in October.

PACLoan 1.0a **Incorporates Windows** Socket Support

tarting with PACLoan Version 1.0a, due to be shipped in June 1993, PACLoan will work with any TCP/IP package that is "Windows Sockets Compliant." NetManage Newt/Chameleon Version 3.1 is "Windows Sockets Compliant," as are many other Windowsbased TCP/IP packages.

The Windows Socket standard is intended to provide a single Application Program Interface (API) to which application developers and multiple network vendors can conform. Incorporating Windows Socket support in PACLoan will allow you a much wider choice of network software vendors.

SAS Makes Release 5.2 More Efficient

his is a reminder to those of you who do not have a SAS compiler that you will need to purchase one for Release 5.2. We are replacing the old PL/1 batch processing with SAS (Statistical Analysis Software).

SAS will make Release 5.2 more efficient and will make it easier for us to support you. Release 5.2 will be available late in 1994. To find out how much SAS will cost your institution and to order the SAS compiler, call the SAS Institute in North Carolina at (919) 677-8000.
