## **Certification Regulation Update Overview**

The Rhode Island Department of Education, as approved by the Council on Elementary and Secondary Education, is proposing changes to the Regulations Governing the Certification of Educators in Rhode Island (200-RICR-20-20-1). The following table is a summary of the changes in the proposed regulations.

1.7.C	Reciprocity	Expanding the interstate flexibility section of reciprocity to the states of Alabama, Indiana, Ohio, Tennessee, and Wisconsin	Expanding interstate flexibilities with additional states could encourage more educators to move to RI to teach.

1.8.12	International Teacher Preliminary Certificate	Added a certificate specific to educators who are certified in another country who wish to teach in Rhode Island temporarily	This eliminates the need to use emergency certificates for these educators.
1.8.13	Fast-Track Principal Preliminary Certificate	Collapsed the Fast-Track Principal Expert Residency Preliminary Certificate and the Fast Track PK-12 Building-Level Administrator Certificate into one Fast-Track Principal Preliminary Certificate	This will lessen confusion in the field.
1.8.14	Registered Apprenticeship Preliminary Certificate	Created a preliminary certificate for those working in a role through a RIDE-recognized registered apprenticeship program	This new certificate area creates an additional pathway to certification.

1.9.2	Elementary Teacher Certificate	Allows educators with a valid Early Childhood, Middle, or All Grades Certificate and three years of teaching experience in Rhode Island to add an Elementary Grades Certificate with evidence of passing the appropriate content test	This will give experienced educators flexibility to move into new positions while maintaining high expectations regarding content knowledge.
1.9.3	Middle Grades Teacher Certificate	Allows educators with a valid Elementary, Middle, Secondary, or All Grades Certificate and three years of teaching experience in Rhode Island to add a Middle Grades Certificate with evidence of passing the appropriate content test	This will give experienced educators flexibility to move into new positions while maintaining high expectations regarding content knowledge.
1.9.4	Secondary Grades Teacher Certificate	Allows educators with a valid Elementary, Middle, Secondary, or All Grades Certificate and three years of teaching experience in Rhode Island to add a Secondary Grades Certificate with evidence of passing the appropriate content test	This will give experienced educators flexibility to move into new positions while maintaining high expectations regarding content knowledge.
1.9.5	All Grades Teacher Certificate	Allows educators with a valid All Grades Certificate and three years of teaching experience in Rhode Island to add an additional All Grades Certificate with evidence of passing the appropriate content test	This will give experienced educators flexibility to move into new positions while maintaining high expectations regarding content knowledge.
