Georgia Sea Grant, in partnership with 12 other Sea Grant programs, was awarded a \$500,000 grant from the [National Science Foundation CoPe program](#) to study human displacement and relocation caused by climate change, and the societal and economic implications of such population shifts. The newly formed research coordination network hopes to increase community participation in climate research and adaptation studies conducted in regions that have been identified as vulnerable.

## California Sea Grant Launches Commercial Fishing Apprenticeship Program

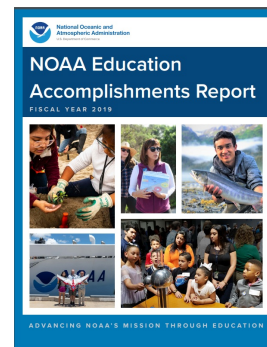

**[Sea Grant Career Opportunities:](#)** Sea Grant has several job openings across the country, including Coastal Dune Restoration & Management Coordinator at Hawai'i Sea Grant, Great Lakes Fisheries and Ecosystem Health Specialist Extension Associate at New York Sea Grant and Science Management and Policy Internship at Maryland Sea Grant.

**[Sea Grant Aquaculture: Addressing Economic and Market Needs of the U.S. Aquaculture Industry](#)** Subject to the availability of funding, Sea Grant anticipates approximately \$5,000,000 will be available for research projects and programs that will significantly advance the understanding of the economics of aquaculture businesses in the U.S. and address gaps regarding important market information. The overall goal is to advance business management towards development of a sustainable marine and Great Lakes aquaculture industry in the U.S. All proposals to this competition must be submitted by a Sea Grant program. Other interested entities must submit proposals in partnership with and through a relevant Sea Grant Program. Notices of intent to submit are due February 26, 2020. Full proposals are due April 22, 2020.

**[Sea Grant American Lobster Research Program](#)** This program will support research to address critical gaps in knowledge about how the American Lobster and its fishery is being impacted by environmental change. It is informed by listening sessions with regional fishing industry stakeholders, state and federal fisheries managers, and university, state and federal fisheries researchers. Applications are due March 19, 2020.

**[NFWF Fishing for Energy Partnership 2020 Request for Proposals](#)** This competition provides up to \$500,000 in grant funding to support strategies that reduce the impacts of derelict fishing gear on marine and coastal environments and navigational safety. The deadline for full proposals is Tuesday, March 31, 2020.

**[Sea Grant Support of Workshops and Meetings](#)** The National Sea Grant Office (NSGO) anticipates that up to \$60,000 in FY 2020 Federal Funds will be available to individual Sea Grant Programs in order to support activities at workshops, conferences or professional meetings that are directly in support of each Program's 2018-21 strategic plan and/or in alignment with goals and actions identified in the "network visioning" plans developed in 2017-18. Applications are due April 13, 2020.

**[NOAA Ocean Acidification Education Mini-grant Funding Opportunity](#)** NOAA's Ocean Acidification Program presents a mini-grant initiative to fund ocean acidification outreach that engages communities through innovative approaches, such as data visualization, multimedia tools, hands-on labs and citizen science. Applications are due April 3, 2020.
