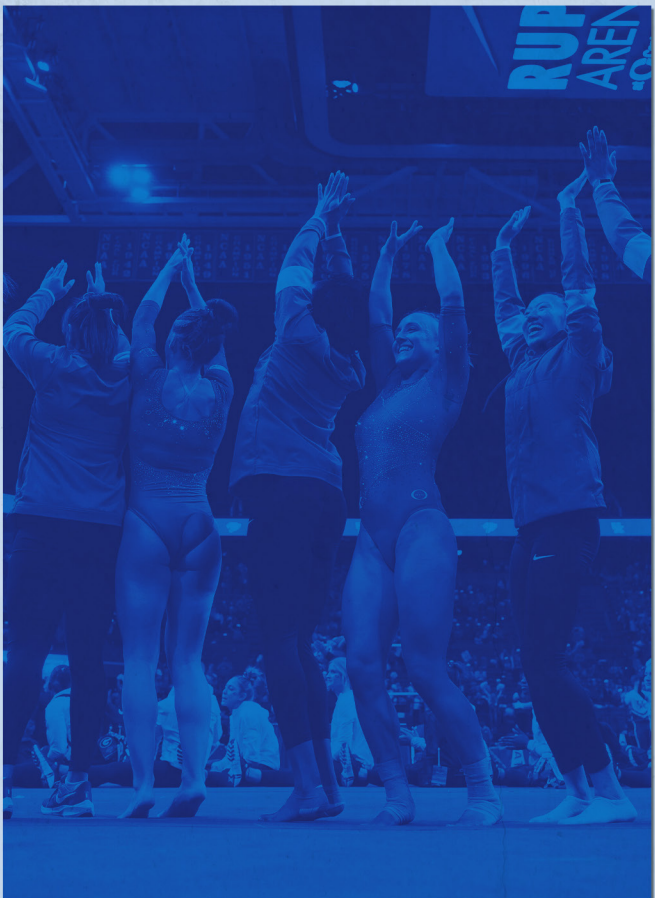

Please note that with the passage of the Tax Cuts and Jobs Act of 2017, contributions made on or after January 1, 2018 may no longer be deductible for tax purposes to the extent the donor receives (directly or indirectly) the right to purchase tickets for seating at an athletic event at the University's athletic facilities. In all cases, the University of Kentucky recommends that you consult with and rely upon the advice of your tax professional regarding the deductibility of your contribution.
