Archival Program: The Dr. John P. De Cecco Archives and Special Collections of the GLBT Historical Society had a successful year despite limited onsite access due to the COVID-19 pandemic. We improved digital access and added new online resources, updated catalog records, and created new finding aids and research guides to enhance collection searchability. We broadened and strengthened our digital collections, with a special focus on documenting LGBTQ Black, Indigenous and people of color (BIPOC) communities. We added 23 new digital collections, including thousands of pages of ephemera, audiovisual recordings and historical photographs. Additionally, we finalized our inventory of the over 1,000 objects in our Art and Artifacts Collection and made a significant selection of photographs of these objects available online. On the website, we redesigned the Online Resources portal (cont'd at Schedule O)

Public Exhibitions: The GLBT Historical Society Museum in San Francisco remains a key setting for the GLBT Historical Society to share our past with LGBTQ and non-LGBTQ publics and to advocate for the preservation of queer history and culture. As a result of the COVID-19 pandemic and work-from-home limitations throughout the year 2020, the museum's offerings and cultural contributions remained constant by serving visitors and media from around the world. Once we established that we would not be able to conduct any in-person events or install any exhibitions that were already planned to open in 2020, we immediately pivoted towards a digital format to replace all in-person exhibitions and related public programming. As a result, this year we created and made available 6 online exhibitions and collaborated with 10 diverse community curators. (cont'd at Schedule O)

Public Education Program: 2020 and the COVID-19 pandemic drastically altered the workflows and ways in which we as an organization schedule, curate, present, and distribute our public programming calendar. While we were forced to put in-person programming events on indefinite hold, we implemented virtual/online programming that drastically increased our reach, ability to invite speakers from geographic locations that were previously inaccessible to us, and gave us the ability to document and archive all public programming for future engagement for constituents who were not able to attend the live events. We invited over 150 speakers and panelists (from 4 different continents) to take part in programming or present with the society, collaborated with 6 different partner institutions and organizations for co-sponsorship of events, (cont'd at Schedule O)
