Reporting Requirements. This program requires that participants use Comet-Planner, however on a case by case basis some participants may have to utilize Comet- Farm depending on the practice.

*28 Practice Note. The purchase of cattle is a supporting practice in the 528 prescribed grazing practice. Applying for this practice must show a true benefit in relation to prescribed / rotational grazing.
