The National Archives and Records Administration (NARA) has become aware of an unauthorized disposition of a box of records in transit between the Riverside Federal Records Center and your agency's office in Tucson, AZ via UPS.

In accordance with 36 CFR 1230.14, please provide us with a report within 30 calendar days that includes the following information:

- A complete description of the records with volume and dates if known;
- The office maintaining the records;
- A statement of the safeguards established to prevent further loss of documentation; and
- Details of the actions taken to salvage, retrieve, or reconstruct the records.

We understand that this loss has already been reported to UPS who has completed an investigation and deemed this box lost.

The National Archives and Records Administration (NARA) has received the report from the Executive Office for the U.S. Attorneys (EOUSA) in response to our letter dated February 27, 2023, in which we requested that EOUSA provide NARA with a report regarding a box of records that went missing via transit between Riverside Federal Records Center and the United States Attorney's Office (USAO) office in Tucson, AZ.

According to the EOUSA report, the USAO initiated the permanent withdrawal of Case #2013R20340, *U.S. v. Jon Frederick Ewens* (April 18, 2013 - April 12, 2019). These records were permanently withdrawn to update an erroneous disposition authority (records were initially scheduled under disposition authority N1-118-10-7-3 and needed to be rescheduled under N1-118-10-7-B1) and also for review by an attorney. We understand that this loss has already been reported to UPS who has completed an investigation and deemed this box lost. EOUSA estimates that 50 percent of the lost files can be reconstructed.

In order to mitigate future incidents, EOUSA will continue to transition to electronic recordkeeping, and in the interim, will continue to work with UPS to see if the box can be recovered.
