This form is necessary to certify that you have sufficient funds for your first year of study. A Certificate of Eligibility (Form I-20) for a Student Visa will not be issued unless this form is completed and the necessary certifications are obtained. In order to obtain a visa to study in the U.S., you will also be required to demonstrate to the U.S. Consular post that you have adequate financial support for the upcoming academic year. You may wish to retain a photocopy of this document for your records.

You may, along with this form, submit documents confirming available funds for the annual costs of study, such as online deposit accounts or a signed bank letter verifying the ability to pay all educational expenses. Funds must be currently available or liquid; bank statements must be dated within 12 months of your start date at Boston University and written in English.
