## Melon and Vegetable Adjoining State Movement Permit

The provisions of the California Food and Agricultural Code (FAC) Section 43571 allows melons and vegetables to be transported in field bins or bulk to an adjoining state for first handling and packing provided the statutory requirements are met.

By signing this permit, the Grower/Handler (permittee) agrees to ensure the melons or vegetables are not vacuumed packed or cooled in California prior to transportation to the adjoining state packing facility, are inspected by a destination state official to ensure the melons or vegetables comply with California maturity, quality and packing requirements and agrees to communicate all information associated with the harvesting and shipments of all produce transported under this permit, to the Production County Agricultural Commissioner and the Destination State Official.

In addition, the Grower/Handler must be registered with the Standardization Program, submit monthly shipment reports and pay all required assessments as outlined in FAC Section 42808. Grower/Handlers involved in the production and packing of cantaloupe melons must also register with the California Cantaloupe Advisory Board and comply with the Cantaloupe State Marketing Order as outlined in FAC 58741.

This permit shall be valid for a period not to exceed 180 days and may be renewed for successive 180-day periods. This permit may be revoked or suspended for failure to comply with any of the requirements specified. The permit holder is responsible to obtain a new permit prior to the movement of any melons or vegetables to an adjoining state that fail to comply with California Laws.
