Lisa Krieg, Director of Enrollment Services—Update on SIO

- Enrollment services encompasses the Hub, ID Office, University register, etc.
- Update on FCEs and E-Bills.
- Completely rehabbing the enrollment services websites.
- Changing the Faculty Course Evaluations (FCEs) with additional questions
 - o Going back to a 10 question format.
 - o Current UCAs—only 35% participation among students.
 - Period for FCE completion is being extended through exams.
 - In place by end of spring term.
- Working on rehabbing entire student services suites.
- Tackling projects one-by-one to slowly improve services.
- E bills launched in October.
 - About 2,600 undergrads authorized their parents to receive their e-bills. Most authorizations came from freshmen, sophomores, and juniors.
 - Send out paper notices and emails to families not yet authorized.
 - o Possible that people are missed or that people who are authorized are.

5:23 Questions

- (Flittner) What about making the process more gradual?
 - Will see Friday if it is effective.
- (Adams) Could not see specific line items; did not see the detail expected. Had to go into SIO account to see more specific charges.
- (Tuttle) Any leniency for people who mess up?
 - At end of each month there are late fees 1.25% of owed money. And don't put late charges until the end of the month. Students can also come to the HUB individually if there are extenuating circumstances.
- Have both the parents and the students respond. Focus on the families/students who don't respond
- Don't always have parent emails which limit outreach.
 - FERPA—students grant parents the right to see bills, meant to protect privacy.
- SIO improvements:

- Have targeted alerts and announcements to make it more interactive.
- o Incorporated schedules and planning with student information.
- Advantage is that it's real time opposed to scheduleman.
- E-check improvements.
- Housing assignment and roommate display.
- New SIO will have a logout button.
- Student's name will be displayed on all pages.
- Will be able to electronically move schedules.
- Will be able to print out unofficial transcripts, financial awards, and bills. And have tips on all pages.
- Can print pdfs of schedules in calendar or list form.
- o Easier to browse by keywords, departments, etc.
- Be able to store multiple versions of a schedule.
- Graphically display GPAs...
- (Pandey) Have certain functions on how to display GPA.
- Would graphically displaying GPAs put undue pressure on students?
- (Flittner) Some people don't want to see their GPAs compared to the rest of the University.
- (Schneider) No particular benefit; just more stressful.
- (Tuttle) More people are aware of how they are doing. Would only be a constant reminder of not excelling.
- Maybe have options where it only includes major GPA, but the current system does not have that capability.
- Also have an option that distinguishes between GPA and QPA.
- (Flittner) Doesn't really enrich your experience if you're excelling and hurts students who aren't doing as well.
- (Adams) See the positives that if it's a straight line and then dips, then a student can graphically see how their grades have fallen.
- (Lu) Graph is hard to read at first—needs an explanation.
- (Schneider) Lots of students will be upset but it seems like a good tool for advisors.
- Print out grades by selecting options. It is a separate process from official verifications.
- Give history of payments and account activity.
- Will have pdfs of financial aid award letters.
- Advisors can contact house fellows and college liaisons.
- (Flittner) Are you centralizing FCEs?
 - Will not happen in this release.
- Registration, scheduling, and link to catalog/course descriptions and FCEs.
- Had to limit in terms of resources and time frame—only the short list.
- Make course names fit so that employers can see what classes students have taken.
- (Adams) Will the schedules be able to be shared?
 - Could email pdfs but don't have a mechanism for people to save it on a separate URL.
- (Pandey) No immediate code for building abbreviations.
- (Zhang) Will OLR be accessible after 10 PM?
 - No, has to do with the age of the system. Are slowly modernizing the entire system but the underlying system remains unchanged.
- It's a new layer on the old system.
- This is a phase but it's modular enough that it can be changed.
- Voting on name and background.
 - o SI, MySI, PlaidNet, and Maggie
