Saaxiibka Qaaliga ahaaw:

Sidaa an ka aragnay wararka kasoo baxaya dhammaanba waddanka ee ku saabsan xadgudubyada yuhuud nacaybka ah, oo ay kujiraan dugsiyadu,¹ waxaan waraaqdaan kuugu soo qoayaa inaan ku xasuusiyo waajibaadka sharci ee dugsiiga saaran si waafaqsan sharciga Title VI ee Xeerka Xuquuqaha Bulshada ee soo baxay 1964 (Title VI) si ardayda dhammaantood ay u helaan, oo ay kujiraan kuwa Yuhuudda ah, jawi waxbarasho oo laga ilaaliyay takoor ku salaysan isir, midab, ama gobolka qofku kasoo jeedo, oo ay kujiraan isir wadaagga ama dabecadaha qolo gaar ah.

Horaantii sanadkaan, Xaafiiska Waaxda Waxbarashada ee loogu talagalay Xuquuqda Bulshadu (OCR) waxa uu soo saaray warqad macluumaad - [Ka difaacidda Ardayda Cunsurinimada ku Salaysan Isirkooda ama Habdhaqanka qoladoodaa](#) – ayada oo sharaxaysa sida ilaalinta ay bixiso Title VI, taas oo mamnuucda midab takoorka ku salaysan sinjiga, midabka, ama meesha ay asal ahaan ka yimaadeen laguna samaynayo barnaamijyada ama waxqabadyada caawinaada dhaqaale ee ka timaada fadaraalka, waxa uu gaarayaa ardayda kuwaas oo la kulmay midab takoorka, oo ay ku jirto handadaada, taas oo ku salaysan sifooyinkooda asal raaca ama abtirsiima wadaaga ay wadaagaan kaas oo xaqiiq ku salaysan; ama(ii) loo aqoonsaday:(i) muwaadin ama degan wadan ay u badantahy hal diin ama leh aqoonsi diimeed kala duwan.²

Title VI waxa uu ardayda oo dhan ka ilaalinayaa, oo ay kujiraan ardayda ah ama la rumaysan yahay in ay yihiin Yuhuudda, takoorka ku salaysan isirka, midabka, iyo waddanka ay kasoo jeedaan. Tusaale ahaan, OCR waxaa laga yaabaa in uu baaritaan ku sameeyo [cabashooyinka](#) ah in ardayda lagula kacay xadgudubyo ha ahaato asalkooda ama abtirsiimada; taas oo lagu handaday sida ay u egyihiin, ay u labistaan ama ay u hadlaan taas oo lagu xariirinayo asalka ama abtirsiimada (tusaale., midabka jirka,

labis diimeedka, luuqada hadalka); ama aragtida ku salaysan in loo aqoonsaday abtirsiiimo ama sifooyinka asal raaca.

Duqsiyadu waa in ay talaabo degdeg ah oo ku haboon ay ka qaadaan si ay uga jawaabaan xadgudubyada keenaya jawiga colaadda abuuraya.³ OCR waxa uu si guud u ogaaday in jawiga colaaddu uu kajiro meesha uu kajiro hab-dhaqan xadgudub ah kaasoo heerkiisu sareeyo, baahsan, ama joogto ah si loo carqaladeeyo ama loo soo koobo awooda shaqsiyadeed si uga qaybqaato ama ka faaiidaysto adeegyada, waxqabadyada, ama mudnaanta dugsigu bixiyo.⁴

Hadii haddii jawi cadowtooyo oo isir ku salaysan jiray, dugsiguna uu ogaama ama laga rabay inuu ogaado jawiga cadowtooyada ah, OCR wuxuu qiimayn doonaa in dugsigu gutay waajibaadkiisii si waafaqsan Title VI oo ah inuu qaado talaabooyin degdeg ah oo wax ku ool ah si sax ahna looga fakaray si loo dhameeyo xadgudubka, meesha looga saaro jawi kasta oo cadaawad abuuraya iyo saamayntiisa, loogana hortago in xadgudubku soo laabto.⁵ Hadii si kale loo dhigo, dugsigu waxa uu jabinayaa Title VI marka uu ku guul daraysto in uu talaabooyin ku filan uu ka qaado si uu u soo gudbiyo xadgudubka midab takoorka, sida xadgudubka Yuhuud nacaybka.

OCR waxa uu hirgaliyay ilo badan oo kala duwan si uu dadwaynaha uga caawiyo barashada mudnaanta ay leedahay in la joogteeyo bay'ad ka fog xorna ka ah midab takoorka oo ay ku jirto midab takoorka ku saabsan abtirsiiimada ama sifooyinka asal raaca ama muwaadinimada ama wadan ay hal diin u badantahay ama aqoonsiga diinta. Fadlan fiiri liiska illaha hoose kuwaas oo laga yaabo in aad u aragto in ay ku caawin karaan.
