  - Seven elected Members of the General Committee;
  - Nine Members of the Credentials Committee; and
  - Seven Members of the Resolutions Committee.

### **Introduction**

1. As decided by the 36<sup>th</sup> Session of the Conference (November 2009), the 37<sup>th</sup> Session of the Conference will be held in Rome from 25 June to 2 July 2011.
2. This document complements arrangements for the 37th Session of the FAO Conference (25 June - 2 July 2011) approved by the Council at its 140th Session (November-December 2010), which are set out in C 2011/12, including the proposal that the theme for the General Debate of the Conference under item 10 "Review of the State of Food and Agriculture" be "The Vital Role of Women in Agriculture and Rural Development".

### **Tentative Timetable**

3. A tentative timetable for the Conference (*Appendix A*) is submitted for consideration by the Council and submission to the Conference for approval.

### **Officers of the Conference**

4. The Council at its 140<sup>th</sup> Session (November-December 2010) expressed consensus for the nomination of His Excellency Teferra Derebrew, Minister for Agriculture and Rural Development of Ethiopia as Chairperson of the Conference and, furthermore, recommended that the Chairperson of Commission I be from a country not within the G77 and that the Chairperson of Commission II be from a G77 country.<sup>1</sup>
5. At its 141<sup>st</sup> Session the Council is requested to nominate candidates for the following positions:
  - (i) Chairperson of Commission I;
  - (ii) Chairperson of Commission II;
  - (iii) three Vice-Chairpersons of the Conference;
  - (iv) seven elected Members of the General Committee;
  - (v) nine members of the Credentials Committee; and
  - (vi) seven members of the Resolutions Committee.

### **Informal Meeting for Non-Governmental Organizations**

6. As at previous sessions of the Conference, it is proposed that observers from Non-Governmental Organizations be invited to attend an informal meeting on Saturday 25 June, so that their advice and suggestions on the Organization's activities and programmes may be communicated to the Conference.
