Paper logbooks are required to be completed and submitted for federally permitted vessels over 60 feet in length that are fishing for groundfish and for vessels that are 25 feet and over in length fishing for IFQ halibut. The submission of electronic logbooks is required for trawl catcher/processors participating in the American Fisheries Act (AFA) and Community Development Quota (CDQ) pollock fisheries in the BSAI, trawl catcher/processors participating in the Central GOA rockfish program, and longline catcher/processors fishing for Pacific cod if required to weigh the Pacific cod on a NMFS-approved scale. Some other catcher processors and catcher vessels voluntarily submit an electronic logbook instead of a paper one.

Electronic logbooks can be submitted to NMFS in two ways, either as an attachment to an email or through the use of eLandings or seaLandings and transmitted to the Interacency Electronic Reporting System (IERS) repository database. The email attachments are saved and the files are loaded into NMFS AKRO Oracle tables. Electronic logbooks transmitted by eLandings or seaLandings are extracted from the IERS repository database and loaded into NMFS AKRO Oracle tables.
