Coho salmon Lower Columbia River ESU critical habitat for use in ESA/FIFRA consultations

### 1.2. Summary description of the data:

These data represent critical habitat designated (February 24, 2016, 81 FR 9252) under the Endangered Species Act for the Lower Columbia River coho salmon ESU. Critical habitat includes the stream channels within the designated stream reaches, and includes a lateral extent as defined by the ordinary high-water line (33 CFR 319.11). In areas where ordinary high-water line has not been defined, the lateral extent is defined by the bankfull elevation. Bankfull elevation is the level at which water begins to leave the channel and move into the floodplain and is reached at a discharge which generally has a recurrence interval of 1 to 2 years on the annual flood series. Critical habitat in lake areas is defined by the perimeter of the water body as displayed on standard 1:24,000 scale topographic maps or the elevation of ordinary high water, whichever is greater. See the final rule (81 FR 9252) for descriptions of areas excluded from this critical habitat designation. Excluded Habitat Conservation Plan (HCP) lands were not clipped out of the data.

- 2019-07-17 00:00:00 - FCH\_COLCR\_Designated&Excluded\_6-6-16.shp ( NAD\_1983\_Oregon\_Statewide\_Lambert\_Feet\_Intl) geographic transformation, unprojected -> COLCR\_ch.shp (GCS\_North\_American\_1983 wkid 4269). Geometry was edited (deleted features), attributes were not edited, metadata was edited. Deleted features were those with Econ\_Excl = "Exclude - Economic Impacts" (i.e., removed economic exclusion features that were not designated).
- 2021-04-26 00:00:00 - The 2019 version COLCR\_ch.shp (GCS\_North\_American\_1983 wkid 4269) was converted into the standardized feature class SalmonCoho\_LowerColumbiaRiverESU\_20160224 (GCS\_WGS\_84 wkid 4326) using the National Critical Habitat Geodatabase processing protocol. During standardization, geometry was not edited. Attributes were edited. Metadata was edited and populated using the final rule and metadata from the source FCH\_COLCR\_Designated&Excluded\_6-6-16.shp ( NAD\_1983\_Oregon\_Statewide\_Lambert\_Feet\_Intl). Migrated fields: "STRM\_NAME" into "UNIT" (deleted value "unnamed"), "USEDESC" into "NOTES" Dropped fields: FID, HUC5, USE, LENGTH, HCP\_Excl, Econ\_Excl, Final\_CH
- 2023-03-30 00:00:00 - As described above, this species' HUC-based critical habitat dataset was modified from the line-based species "agency-official" NMFS critical habitat data. This HUC-based critical habitat file represents the HUC-12 watersheds ( USGS Watershed Boundary Dataset; <https://www.usgs.gov/national-hydrography/watershed-boundary-dataset>) that intersect with the "agency-official" critical habitat line-based data. The data were reviewed and revised to add any additional HUC-12 watersheds that were determined to have hydrologic connectivity to the critical habitat.
