SINQ 20240039

Update to Current Manual/Race: For the Example #15 under Race Coding Examples in the 2024 SEER manual, could coding these as 97 result in an under-reporting of Native Hawaiians?

The race category in some hospital electronic medical record systems includes a combined category of "Native Hawaiian/Pacific Islander." What race code should be used in a situation where the only available information is "Native Hawaiian/Pacific Islander?"

Change to current instructions. We will update this example in the next edition of the manual. The new example will instruct registrars to look for other descriptions of the patient's race. When no other information is available, assign 07, Native Hawaiian, in Race 1 and assign 97, Pacific Islander, NOS in Race 2. Begin following this new instruction now.

Be on the lookout! Soon facilities will receive results from a neoadjuvant breast audit performed for diagnosis year 2023. This audit reviewed neoadjuvant data items. Results will be discussed at the SEER Workshop and KCR Fall Conference.

Update to Current Manual/Race: How is Race coded when stated as Hispanic and there is no other information?

There appears to be discrepant information in the 2024 (and prior) SEER manual regarding race coding when the patient is described only as Hispanic/Latina. Page 78 tells us to Code as 01 (White) when: b. There is a statement that the patient is Hispanic or Latino(a) and no further information is available

- i. A person of Spanish origin may be any race; however, for coding race when there is no further information other than "Hispanic" or "Latino(a)," assign race as White as a last resort instead of coding unknown.

However, in Appendix D, under "Other Race descriptions", there is a statement that "If no further information is available, code as 99 Unknown." The list includes "Hispanic".

Assign code 01 (White) for Hispanic when there is no additional information. It is listed in the 2024 SEER Manual, Race Coding Instruction 6.b.i. and in Appendix D for code 01. We will remove Hispanic from the list in Appendix D under code 99 in the next version of the manual.

Follow up tips ~ Obituaries

Be extra cautious when using obituaries for follow up purposes. Be sure to confirm the patient's demographic information (DOB, sex, etc.,) matches the decedent. If you have a contact/informant listed for the patient, check to see if they are mentioned in the obituary. If you don't have the patient's DOB, but can calculate their age, make sure it matches the age of the decedent. Do not use unreliable internet sources and websites. If you are unsure if the obituary is the correct patient, do not use it.

Component Summary

Data Exchange	Fixed a bug in NAACCR XML output where only the 1st tumor record is output if a patient record contains multiple records. Any submission files generated between 6/24 and 7/19 may need to be resubmitted to the requesting agency.
Data Exchange	Fixed a bug where SEER SSF1 output was truncated to the old 1-digit code during edits and submission output
Data Entry	Fixed logic for edits for SSDI fields shared between EOD and Pediatric staging to prevent edits from failing when cases are ineligible for Pediatric staging due to diagnosis year restrictions.
Data Analysis	Fixed a bug where an A surgery code prefix was being placed on 2024 surgery sites requiring a B surgery code prefix. The bug only affects surgery code queries and data lists in Data Analysis. Submission output is not affected.
Data Exchange	Updated NCDB/RCRS v24a edits to version released 7/4/2024. Contains updates to allowed surgery codes for N6800 and N6774; Removes Edit N2836; Adds Edit N6892 Ph I, II, III Total Dose, Radiation Volume/Modality (COC)

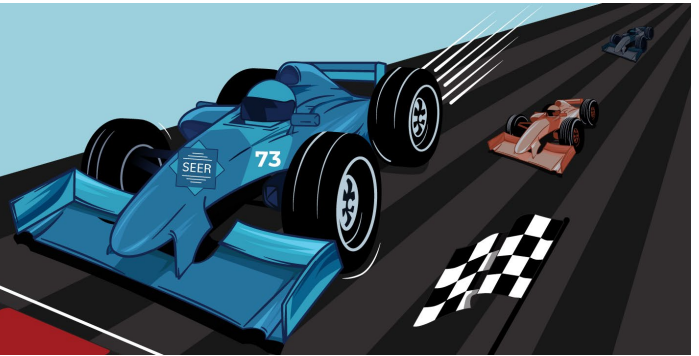

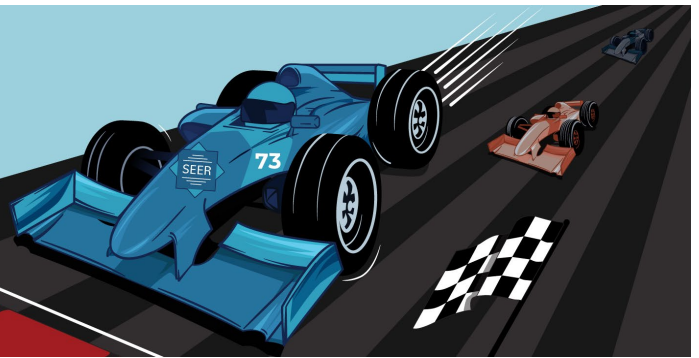

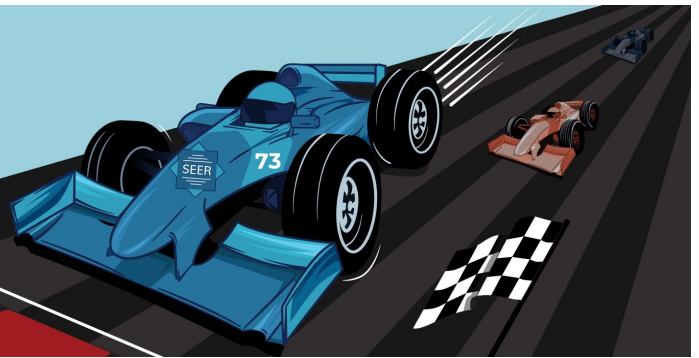
