Nancy Henry, NMEROG – Commented that Inspectors have been responding more quickly to cruelty cases. Commented on current lawsuits and lawsuits which are not listed on the agenda. Also

commented on nine letters from the State Auditor. Comments regarding horses being a problem on the road; the primary reason for car accidents is wildlife in general. Deposit should be within 24 hours is required. Proof of ownership is an issue. Staff should not be slandering members of the public.

## **BOARD CONCERNS:**

Dr. Zimmerman made a comment on behalf of Donald Martinez: the Livestock Board should focus on cattle and do away with sheep inspections. Board Member Lee was also contacted by Mr. Martinez regarding combining three districts into 2 districts.

Handling of estray horses. Director has authority to designate that estray horses go to the rescues. Bill from 2017 session will be reintroduced. The bill allows rescues to have first right of refusal on horses. If they do not take them then they go through the sealed bid process. Senator Woods will also be reintroducing SB 126 with clarification on definition language and will also addresses what public lands are.

Board Member Spradley was approached by a gentleman who asked if the board would look into the potential of allowing brand cards and travel papers through cell phones. Could that be something we could look at in the next year. It may help inspectors to have the brand cards readily available. May also help if you change addresses.

Board Member Van Dussen presented. Barry Allen, Area 1 Supervisor, and Board Member Van Dussen have worked on a proposal to check a whole herd for brands and then be able to write brand inspections off of that initial brand inspection. They did that and it took three hours to do verses checking every single time they ship a load of cows. Shipping cows takes about an hour. It saves time and resources. It could save \$382 for a facility of his size. Couple of ways to regulate is each herd has to have the same owner or going to the same site and having one brand or brand alternative. Positive is save labor, save vehicle and increase time for surveillance on the road and may free up time for employees. Will get a broader look at the facility as well. Pretty much email and text messaging. Save significant amount of money. Still have inspection fee. Change of ownership would have to be brand inspected. Mr. Allen, Area 1 Supervisor, running a test. Only works under confined feeding facility and only one brand and one tag. Sanitation part of the process is a concern. Would need State Veterinarian approval. Does not require a rule change; changing of the fees will need statutory change. Saves time. Herd inspected every two months. Area Supervisor Mora stated someone could introduce something to that herd and the inspector will not know. Inspectors have to verify what the shipment contains. Monitoring is important – spot checking must happen. To move forward we would want the Board's approval. Not an action item for this meeting. Continue to see how it works and report at next Board meeting in March. Area Supervisor Riggs asked to make sure it is along with statute and how our inspectors are trained. She also stated you cannot play with statute on a pilot project. You have to do two inspections. Not outside of statute as it is being done. Board Member Patterson suggests a written proposal and more data before a vote in March.
