Mr. Ty Bays - Grant County Cattle Growers.

This issue was caused by the Forest Service and litigation from the Center for Biological Diversity. He concurs with Mr. Majors; the <u>USFS</u> does not have the legal right to do the aerial killing of cattle. Mr. Bays does not feel the estray rule is applicable to these cattle, in that these cattle cannot be stolen as they are not owned by anyone. In Grant County they are united in one voice, until the Forest Service can find some money to pay contractors, people are willing to go and gather the cattle, but they need the proceeds from those cows. They cannot have the cattle tied up in the estray process. They are asking the Board to allow the proceeds to go to pay the people gathering the cattle. If no action is done soon, the federal government will override our state government to do something as extreme as killing the cattle.

Mr. Buddy Eby - President of Grant County Cattle Growers – also, Retired Livestock Inspector of NMLB for 26 years of service.

Unbranded cattle are a growing problem and needs to be addressed by the Board. These cattle have been running loose on the Gila National Forest for 30 years. There is no former allotment owner to put in a claim for these cattle. The surrounding permittees and private ranchers are deeply concerned about the issues these cattle may cause. Mr. Eby knows the US Forest Service and the NMLB had a MOU in place concerning a previous gathering of these cattle. Upon talking with Rusty McCorkle, he is paid by the USFS, and they put in claims for the cattle and that was how it was handled. For a lien to be put in place, the owner of the cattle must be notified. There is no owner or permittee of the cattle.

Mr. Ralph Pope - Retired US Forest Service Employee.

Mr. Pope worked for the USFS when the wild cattle were gathered previously. He worked in range land management 1972 and retired in 2009. He worked in the Gila Nation Forest in livestock management divisions. He stressed he is not representing the US Forest Service in this situation. He has experience and knowledge when the original lawsuit and gathering took place. He will not try to convince one way or another. Mr. Pope began working with the permittee in 1991 because the cattle were wild and unmanaged. In 1998 the lawsuit was filed for allowing livestock to graze in the riparian areas on the major rivers in the southwest which included the Gila National Forest. After years of trying to manage the livestock, the permittee came forward asking for assistance on the gathering of the cattle so he would not lose all his interest in the cattle. The USFS got with the NMLB, thru many meetings, to set up an agreement on the clearing of the cattle; killing them was not an option. US Forest Service got money and did the impoundment thru contracting with cowboys. There was an agreement with the NMLB, as soon as the cattle were out of the forest, they were inspected to make sure there were no brands. They had something set up with the Deming Livestock Auction and once there, they were turned over to the NMLB, that is where the USFS job ended. They would sell them as estray and if no one claimed them the money would go to the NMLB, and they would take their cost out of the sale proceeds and then make available to the USFS any remaining funds.

GILA NATIONAL FOREST LIVESTOCK DISPOSAL

Director Garland went over what matters were discussed in Closed Executive Session following legal advisement, she would like to make a few comments. Director Garland stated the NMLB can find no statute or rule that allows for estray cattle to be turned over to anyone who gathers them, instead the

estray laws strictly prohibit that act. They can find no statute or rule that allows funds from the sale of estray cattle to be turned over to anyone before the two (2) years expires for claims of ownership to come forward. Director Garland noted, in our opinion the NMLB is not in the business of range management, that was established by the passing of the resolution during the 2021 Legislative Session, regarding the wild horses and range management. There is no authority to alter state law to comply with the Grant County Cattle Growers' request. Director Garland believes the board should take a stance by issuing a letter to all concerned parties that we do not support the shooting of the cattle in the Gila Wilderness. Instead, we encourage the US Forest Service to explore all avenues to pay for the gathering of the livestock and work with NMLB to follow proper estray procedures once impounded. The NMLB has a mechanism for disposal set forth by the NM Legislature. Director Garland reminded the Board on the paying of a lien falls under NMAC 21.32.10.8 Subsection J, pursuant to Section 77-10-4 and 77-2-29 NMSA 1978.

Chair Manzanares stated their job as a public body is not to pick and choose where we follow the law but to administer the laws and policies as evenly and as possible.

Chairwoman Manzanares called for discussion by the Board. Board Member Longinaker asked Director Garland once the impounding is done, does the NMLB takes ownership and decide what to do with the estrays? Director Garland explained once the estrays are impounded there are 5 days for the impounder to notify an inspector at that point they are turned over to the NMLB and they are sold at public auction. The funds will then be held for two (2) years in accordance with state statutes. Board Member Longinaker asked about the legality of allowing the cowboys who gather the cattle to take possession, brand and sell and they keep the money. Director Garland explained Section 77-13-1, possession of estray.

Board Member Padilla-Gutierrez asked the difference between this Gila National Forest issue and the Armendariz issue. Legal Counsel Rasmussen explained there are a lot of similarities, but the Armendariz is on some private land but does not have enough knowledge to go into detail.

No further discussion from the board.
