Pollinator Partnership's Pollinator Stewardship Certification (PSC) program provides home gardeners, land managers, farmers, government, and community scientists with the scientific know-how to make a real difference for pollinators, people, and the planet. The training features expert topic speakers, the latest pollinator research, and provides participants with the information needed to become powerful pollinator protectors. The School Garden Kit (SGKs) program aims to support teachers, administrators, guardians, youth groups, after school programs, amongst others, in guiding students through a discovery process that will increase students' understanding in science, math, and language arts by connecting them to plants, pollinators, food, and gardens by (potentially) creating habitat for pollinators.
