Furthermore, **THIS LIST IS NOT COMPREHENSIVE OF THE CORPORATIONS OR REGISTERED AGENTS THAT MAY PROVIDE SURETY IN THIS COURT.** In accordance with 31 U.S.C. § 9306, a corporation that is approved by the U.S. Department of Treasury that is acting inside the state under whose laws it was incorporated is **NOT** required to file a power of attorney designating an agent for service of process. Therefore, this list does not contain the name of any corporation incorporated in the State of Texas that is currently approved by the U.S. Department of the Treasury to provide surety in this district. Additionally, this list shows the name of the registered agent for the most recent power of attorney on file. Prior power of attorney documents may exist for a company that have not been revoked. Contact the clerk if you have questions.

**NOTE:** Pursuant to 31 U.S.C. 9306(c)(1), if a resident agent is removed, resigns, dies or becomes disabled, the surety corporation shall appoint another agent. The appointment of an additional or new agent requires that a new power of attorney is filed.
