U.S. federal regulations require students to provide evidence of sufficient funds to cover all expenses while attending the University of Alaska Fairbanks. Evidence of funds is required for estimated expenses for one academic year. Some programs charge a surcharge for their courses in addition to regular tuition.

International students are not eligible to apply for U.S. federal financial aid at any time during their studies. International students should search for their own country's banks, embassy, or ministry of education for available financial aid, loan, and scholarship opportunities.

To maintain immigration status undergraduate students must remain enrolled in 12 credits and graduate students in 9 credits every semester (fall and spring).
