GEORGE LONGPRE', PRESIDENT 1 WHEREAS, Staff Senate has established a permanent endowment fund with the 2 University of Wyoming Foundation, and the net income only shall be available to recognize staff; and 3 4 WHEREAS, Staff Senate establishes guidelines and criteria for staff recognition: and 5 WHEREAS, the University of Wyoming staff can be recognized for their 6 7 contributions in many ways other than Recognition Day awards; and 8 WHEREAS, the office of the President of the University of Wyoming graciously 9 contributes to cash awards for Staff Recognition Day; and WHEREAS, Staff Senate has never utilized the expendable portion of their 10 foundation account but has the capability to do so. 11 12 THEREFORE, BE IT RESOLVED that an Ad Hoc committee be formed that 13 will be named the Foundation Account Committee, to study and explore the feasibility of 14 using expendable money from the foundation account for further University of Wyoming staff recognition. 15 16 **CREATION & COMPOSITION---**The committee will be formed beginning in 17 fiscal year 2001, and will be composed of five staff senators with at least one committee member also serving on the Recognition Committee for reporting purposes, and an Ex 18 19
