1 WHEREAS, the Bylaws of the University of Wyoming Staff Senate located in UW Regulation  
2 1-34, section 2, include the roles and responsibilities of Staff Senate, and;  
3 WHEREAS, the Staff Senate Policies and Procedures document is reviewed annually and serves  
4 as a working guideline for daily business, and;  
5 WHEREAS, the Staff Senate Policies and Procedures serves as an introduction of Staff Senate  
6 expectations and procedures to both new and existing representatives, and;  
7 WHEREAS, a unified purpose is vital to the success, legitimacy and consistent meaningful  
8 information exchange between staff, administration and other members of the campus

10 THEREFORE, be it enacted that the Staff Senate Policies & Procedures be amended to insert a  
11 mission statement preceding the Introduction section reading as attached in Addendum A.
