



WARQADA MACLUUMAADKA: Ka ilaalinta Ardayda Takoorka Ku salaysan Isirka La wadaago ama Dabeeecadaha Qolada

Xaafiiska Waaxda Waxbarashada ee Xaqquqaha Bulshada (OCR) waxa uu dhaqangalinayaay Title VI ee Xeerka Xaqquqaha Bulshada 1964, kaas oo dhamaan ardayda ka ilaaliya midab takoorka ku salaysan sinjiga, midabka, ama meesha uu asal ahaan ka yimid barnaamij kastaba ama waxqabad kasata oo ay Waaxdu ka hesho taageerada dhaqaale ee Fadaraalka. Warqadaan maclumaadku waxa ay qeexaysaa qaababka ay ilaalintaanu u daboolayso ardayda ah ama loo aqoonsaday in ay yihiin Yuhuud, Kiristaan, Muslim, Sikh, Hindu, Buddhist, ama koox diimeed kale.

Ilaalinta Midab takoorka ee Title VI

1 Ilaalinta midabtakoorka Title IV ee sinjiga, midabka, ama meesha uu asal ahaan ka yimid waxa uu gaarayaar ardayda kuwaasoo la, kulmay midabtakoorka, oo ay ku jirto handadaada, taas oo ku salaysan sifooyinkooda isir raaca ama abtirssima wadaaga ay wadaagaan ee xaqiqada ku salaysan; ama loo aqoonsaday (i) isir ama dabeeecado ay wadaagaan; ama (ii) muwaadin ama degen wadan ay ku badantahay hal diin ama leh aqoonsi diimeed kala duwan. 2 Title VI waxa uu mamnuucayaa midab takoorka ku salaysan sinjiga, midabka, ama asal ahaan meesha uu ka yimid kaas oo lid ku ah ardayda diin kasta ha haystene, sida ardayda kasoojeeda Yuhuud, Kiristaan, Muslim, Sikh, Hindu, ama Buddhist, tusaale ahaan, marka uu midab takoorku, iskugu jiro:

- sinjiga, asalka, ama abtirsime wadaag ama aragtiyaha ku salaysan;
- sida uu ardaygu u egypt, oo ay ku jirto midabka jirka, aragtida jir ahaaneed, ama sida u u labisto taas oo ka turjumaysa dhaqamada asalka iyo diinta labadaba; iyo
- lajhada shisheeye; magaca shisheeyaha, oo ay kamid yihiin magacyada sida caadiga ah lala xariiriyo in ay wadaagaan abtirsimo gaar ah ama sifooyinka asal raaca; ama ku hadlaya luuqad shisheeye.

3 Sababtoo ah Title VI kama ilaaliyo ardayda midab takoorka ku salaysan kaliya diinta, sida in la diido codsiga ardayga ee iskuulka si uu fasalka uga baaqdo fasax diimeedka, OCR waxa ay cabashooyinka kusalaysan midab takoorka diinta u gudbisaa [Waaxda Cadaalada ee Maraykanka \(DOJ\)](#), taas oo sharci ahaan awood u leh arintaan.

Tusaalooyinka noocyada dhacdooyinka keenikara walaacyada Title VI, ayadoo oo ay ku xirantahay xaqiiqooyinka iyo xaaladaha waxaa kamid ah:

- Arday Yuhuud ah oo dhigta dugsiga dhexe ayaa macalinka u sheegay in uusan badqab ku dareemayn dugsiga sababtoo ah ardayda fasalkiisa ayaa si joogto ah waxa ay boorsadiisa dhabarka, ugu ridaan qoraalo ay la socoto swastikas, waxa ayna sameeyaan salaantii naasiyiinta sidookale waxa ay ku jeesjeesaan xasuujqi Holocaust. Macalinku waxa uu ardayga u sheegay in uu “iska indho tiro waxaaas” uusana qaadin wax tilaaboojin ah oo u ku gudbinayo handadaadaas.
- Ardaydu waxa ay soo gudbiyaan walaac ku saabsan faalooyinka ay ardayda ay isku fasalka yihiinkabixiyaanmarkalagujiroxiisadataariikhda iyo dhaqanka taas oo la xariirta Sikhism, Islam, iyo caadooyinka kale ee ku baahsan Koofurta Asia. Ardayda muslimiintaa waxaa lagu qeexaa, tusaale ahaan, waxa ay ardayda fasalkoodu u sheegaan “adinka ayaa bilaabay 911” waxaana loogu yeeraa “argagixiso.” Dugsiga waxaa lagu eedeeyey in uusan qaadin tilaaboo wax ku ool ah si loo soo gudbiyo warbixinadaas.
- Ardayda Sikh kuwaas oo xirta turban (bahasha madaxa lagu dabooшо) waxaa si joogto ah loogu wacaa “turban” iyo magacyo kale marka ay dugsiga joogaan, waxa ayna ardaydu isku dayaan in ay ka qaadan turban uu ardayga Sikh uu xiranyahay. Ardaydu waxa ay soo gudbiyaan in dagmadku aysan talaabo wax ku ool ah aysan ka qaadin si loo qoro loona gudbiyo warbixinadaas.
